# Judgment

THIS ACTION was heard on May 23, 24, 25, 28, 29, 30, 31, and June 1, 2012 with a jury at the Newmarket Courthouse, in the presence of the lawyers for all parties.

ON READING the jury verdict,

- 1. THIS COURT ORDERS the defendant to pay the plaintiff's damages in the sum of \$431,832.
- 2. THIS COURT ORDERS the defendant to pay pre-judgment interest on the damages in the amount of \$55,530.
- 3. THIS COURT ORDERS the defendant to pay the plaintiff's costs of the action on a partial indemnity basis to May 10, 2012 and on a substantial indemnity basis thereafter, fixed in the amount of \$267,638, inclusive of fees, disbursements and sales tax.
- 4. THIS COURT ORDERS the defendant to pay post-judgment interest at the rate of 3%, commencing from today's date.




